For over 25 years, Sustainalytics has produced analyst reports that rate companies on their environment, social, and governance (ESG) performance. York's subscription provides access to ESG reports, controversy reports, and compliance reports for approximately 3,500 companies.

Start at the York University Libraries <u>homepage</u>. Enter **Sustainalytics** in the search bar, select **Title Keyword Search** from the search dropdown menu, and click **Find**.
